**SUBJECT: LUMA's Request for Brief Extension
to File Presentation**

REQUEST FOR BRIEF EXTENSION TO FILE PRESENTATION

TO THE PUERTO RICO ENERGY BUREAU:

COME NOW, LUMA ENERGY, LLC and LUMA ENERGY SERVCO, LLC
(collectively, LUMA), through the undersigned legal counsel and respectfully state and request
the following:

I. Relevant Procedural Background

1. On July 13, 2026, the Energy Bureau issued a Resolution and Order (the "July 13th Resolution") containing a Revised Preliminary Draft of the Distributed Generation and Microgrid Interconnection Regulation. The Energy Bureau ordered LUMA to file a Revised Draft Technical Interconnection Requirements ("TIR") by August 11, 2026, scheduled workshops for August 25, 2026 (referred to as Stakeholder Workshop 2) at 9:30 a.m., and September 21, 2026 (referred to as Stakeholder Workshop 3) at 9:30 a.m. The Energy Bureau also invited stakeholders to submit comments on the Revised Preliminary Draft on or before August 14, 2026.

2. On July 15, 2026, the Energy Bureau issued a Resolution and Order in Case No. NEPR-MI-2019-0016 (the "July 15th Resolution") scheduling the upcoming Interconnection Progress Report submissions and Compliance Hearings for FY26 and FY27. The Energy Bureau scheduled the Compliance Hearing for the April-June 2026 quarter for Monday, August 24, 2026,

at 10:00 a.m., with the Progress Report and Presentation due August 14, 2026. The Energy Bureau ordered LUMA to provide all relevant representatives with pertinent documents for the compliance hearings, ensure said representatives are ready to answer questions from the Energy Bureau staff and/or Commissioners, and timely file a copy of any PowerPoint presentation, visuals or materials that LUMA intends to use during the Compliance Hearing.

3. On August 5, 2026, the Energy Bureau issued a Resolution and Order (the “August 5th Resolution”) in response to the Joint Motion Regarding the Sequencing of Approval of the Technical Interconnection Requirements filed by the Solar and Energy Storage Association of Puerto Rico (“SESA”), LUMA, and the Independent Consumer Protection Office (“OIPC”) on July 27, 2026. The Energy Bureau vacated the August 11, 2026 deadline for LUMA to file the Revised Draft TIR and ordered LUMA to submit a Comprehensive TIR document for review and approval within fifteen (15) days of the approval of the Interconnection Regulation. The Energy Bureau reminded stakeholders to submit comments on the Revised Preliminary Draft by August 14, 2026, in anticipation of the 2nd Stakeholder Workshop to be held on August 25, 2026, at 9:30 a.m.

4. On August 14, 2026, LUMA filed its Progress Report and Presentation for the April-June 2026 quarter in Case No. NEPR-MI-2019-0016, as ordered by the July 15th Resolution.

5. On August 19, 2026, the Energy Bureau issued a Resolution and Order (the “August 19th Resolution”) providing the agenda for the August 25, 2026 Virtual Stakeholder Workshop. The August 19th Resolution was served on August 20, 2026, via email. The Energy Bureau ordered LUMA to attend the August 25, 2026 Stakeholder Workshop and to provide a presentation no more than twenty (20) minutes in length summarizing its comments on the interconnection of

distributed energy resource systems less than 25 KW, including its position on automatic interconnection and any proposal for pre- or post-energization assessments or study requirements. The Energy Bureau ordered LUMA to submit a copy of its presentation no later than 2:00 p.m. on August 24, 2026.

II. Request for Extension of Time

6. LUMA respectfully requests an extension of time to submit the presentation ordered by the August 19th Resolution for the Virtual Stakeholder Workshop scheduled for August 25, 2026. The Energy Bureau has ordered LUMA to submit a copy of its presentation no later than 2:00 p.m. on Monday, August 24, 2026. LUMA respectfully requests that this deadline be extended to 6:00 p.m. on the same day.

7. The basis for this request is that the LUMA officers responsible for preparing the presentation, who possess the requisite technical expertise regarding interconnection matters, will be present at the Energy Bureau on the morning of Monday, August 24, 2026, attending the Compliance Hearing in Case No. NEPR-MI-2019-0016 scheduled for 10:00 a.m. Given their attendance at the Compliance Hearing in the morning, these officers will require additional time to finalize the presentation materials after the hearing concludes. LUMA anticipates that the Compliance Hearing will require the full attention and presence of these technical experts throughout the morning, making it impractical to complete the final preparation and filing of the presentation by the 2:00 p.m. deadline.

8. LUMA submits that this limited extension will not prejudice any party or disrupt the scheduled proceedings. The extension of four (4) hours will allow LUMA's technical team to

fulfill their obligations at the Compliance Hearing while also ensuring the Energy Bureau receives a complete and accurate presentation.

WHEREFORE, LUMA respectfully requests this Honorable Energy Bureau to **GRANT** the requested extension of time to file the presentation for the August 25, 2026 Virtual Stakeholder Workshop from 2:00 p.m. to 6:00 p.m. on Monday, August 24, 2026.
